April 2017 saw the Australian Government grant tax-deductibility for donations to ALI to support overseas projects. Members and past donors have since then raised over \$2000 with more promised in the near future. We hope this continues, and also makes ALI more attractive to the corporate sector.

Of late, a vital new role for Landcare has emerged - acting as the community's cornerstone after major disasters such as fire, flood and cyclones. This will be one of the cornerstones of the first conference international Landcare outside Australia. ALL which is with sponsoring in Nagoya our SPELJ counterpart Japanese and Nanzan University's Institute for Social Ethics. This gathering of Landcare academics and practitioners will discuss theories, practice and pragmatics of Landcare, localism, self-reliance,

sustainability. rural and regional resilience and post-emergency and recovery, application disaster for globally. Countries being represented include USA, South Africa, NZ, Kenya, Cambodia, the Philippines, Pakistan, Iceland and Japan, of course.

This money will go to travel grants and speakers travel and accommodation, including some overseas participants.

ALI recently took part in a workshop led by Prof Andrew Campbell, CEO of ACIAR. A group of Victorians, including several of our members, contributed ideas on new research projects and on Landcare training and dissemination of ideas and techniques.

Finally, we need more recruits to ALI, and to spread the action – to have cells of international Landcare activists in every state. I like to think we are heading steadily towards that goal, and that the Nagoya experience will result in new participants around Australia.

On-line courses on Natural Resource Management

I recently completed an on-line, university based course on Landscape Restoration for Sustainable Development: a Business Approach. It was an 8 week course with a final exercise for assessment by fellow students and lecturers.

It is the first on-line course I have ever attempted some 40 years after my last university studies, and I quite enjoyed being stretched with new ideas, particularly economically based views of land restoration. There was a strong emphasis on community based action to address broad-scale problems of land degradation and unprofitable land use. A very Landcare approach !

The course came from the Erasmus University Rotterdam with additional input from lecturers from universities in Iceland and the UK. The PowerPoint summaries and the on-line exercises discussions with other students and were very clear and helpful. Students came mainly from European countries but there were a few from Asia, Africa and South America. The basic course was free but a fee of about \$60 US was charged for a certificate of course completion. The course was one of numerous courses found under the Coursera brand (www.coursera.org) which draws on staff from many wellknown universities around the world. Horrie Poussard

New International Landcare conference in Japan

The first International Landcare Conference outside Australia will be at Nagoya in Japan on 5-8th November, 2017. Nagoya, about half way between Tokyo and Osaka in central Japan. The conference will be conducted in English and there are no conference fees. The last International Landcare Conference was held in Melbourne in 2006 – more than 10 years ago. But time is short if you want to book in !

The Nagoya conference is being organised by Dr Mick Seigel and his team at Nanzan University Institute for Social Ethics with the title **Global** resilience through local self-reliance - the Landcare model.

The conference is expected to have around fifty participants from various countries with lots of opportunity to swap ideas and experiences. It will focus on Landcare research and practice – social science, community development, practical outcomes, policy and funding impacts.

The conference has gathered a good set of international speakers including Prof Andrew Campbell, (formerly of Charles Darwin University and now head of the Australian Centre for International Agricultural Research, Prof Yvonne Everett (Humboldt University, USA), Dr Nick Edgar (New Zealand), Gudmundur Ingi Gudbrandsson and Dr Andres Arnalds (both of Iceland) and Jen Quealy, and Dr Ross Colliver (Australia)

The Australia-Japan Foundation and the World Business Council for Sustainable Development (WBCSD) have generously supported ALI to fund many of the speakers for the conference. Some additional grants have been awarded to participants to assist with travel costs.

ALI in partnership with CSU in Timor Leste

ALI is pleased to be a partner with Charles Stuart University (CSU) in a new project which has been awarded funding by the Darwin Initiative, a UK based funding group. The project is focused on natural regeneration and agroforestry in the Manatuto district in Timor Leste.

ALI provides a small financial support to the project as part of our on-going interest in Timor Leste. ALI Member Dr Jo Millar has been the key initiator of the project. A significant element of the project is improved biodiversity conservation and carbon payments through an internationally recognised carbon accreditation scheme. The not-General Training for-profit Northern Territory (GTNT) will be providing the main on-ground support and training for the project, along with World Vision Timor.

We have given several OLP grants to other projects in Timor Leste previously and we are supporting CSU on another Darwin Initiative project in Bhutan. The new Darwin Initiative project grant totals about \$500 000 over three years. It will support some local forestry staff and provide materials and labour for extensive community planting. Plantings of native and introduced species for timber and biodiversity (eg mahogany, teak, endangered species) and food trees (eg coffee, tea, cashew, fruits, honey) will be scaled up to 260ha.
